Registration: All registrations for summer camps require a minimum 50% deposit, along with a postdated check for the remaining balance, payable 60 days prior to the start of camp. Credit card payments, money orders and or cash are accepted. Registrations received without payment will automatically become void and invalid if proper payment is not received within 14 days, \$25.00 charge for NSF checks.

Cancellations: Prior to 60 days to start of summer camp, all monies are refundable with the exception of a \$75.00 administration fee. Within 60 days of the start of summer camp all monies are non-refundable with the exception of medical reasons.
